## L.N. 523 of 2010

VALUE ADDED TAX ACT  
(CAP. 406)**Legal Notice 499 of 2010 which amends the Eighth Schedule to the Value Added Tax Act (Amendment) Regulations, 2010**

IN exercise of the powers conferred by articles 19(2) and 75 of the Value Added Tax Act, the Minister of Finance, the Economy and Investment has made the following regulations:-

Citation and commencement.

L.N. 499 of 2010.

Amends regulation 1 of the Legal Notice.

**1.** The title of these regulations is the Legal Notice 499 of 2010 which amends the Eighth Schedule to the Value Added Tax Act (Amendment) Regulations, 2010, and these regulations shall be read and construed as one with Legal Notice 499 of 2010 which amends the Eighth Schedule to the Value Added Tax Act, hereinafter in these regulations referred to as "the Legal Notice".

**2.** Regulation 1 of the Legal Notice shall be re-numbered as sub-regulation (1) thereof, and immediately thereafter there shall be added the following new sub-regulation:

"(2) These regulations shall come into force on the 1st January 2011."
